

Each inductee is presented with the specially cast bronze Ranger Hall of Fame medallion, suspended from a red, white and blue ribbon. The medallion was designed and drawn by Mr. C.J. (Duke) DuShane, past President, 75th Ranger Regiment Association who served in combat with P Company, 75th Infantry (Ranger) during the Vietnam War. The eagle represents strength and in Native American lore symbolizes the warrior. The United States flag represents the proud commitment to our country. The arrows show resolve and the readiness to fight and defend the Constitution of the United States against all enemies, foreign and domestic. The eagle flies over the Ranger Memorial acknowledging the courageous and selfless contributions of past Rangers to their country, the United States Armed Forces, and to the proud tradition of today's Rangers. The laurel wreath represents the Rangers' competitive spirit and will to succeed, regardless of the challenge. The Sikes-Fairbaine stiletto represents the Rangers' ability to successfully plan and conduct special operations. Together, the medallion signifies selfless sacrifice, professional excellence, and remarkable accomplishments in the defense of the greatest nation in the world and to the highest ideals of service.

### PRESIDENTS MESSAGE

By the time that most of you read this I and Rick Ehrler and two other members of E/50th /E/75th should be in or have just returned from Vietnam. We are part of a tour group that consists of 18 men who served with various units of the 9th Inf Div in III and IV Corps of Vietnam. And that's the area where we will be spending the majority of our time...among the rivers and swamps of that very fertile area of southeast Asia. According to the information received about the tour we can go almost anyplace that we wish, except where there is currently a military base. That rules out such high points

as Nha Be, a former PBR/Seal base that we were fortunate enough to spend several weeks at back in 1968. Those Navy guys sure did live and eat well. Well..its a Vietnamese Navy base now. Probably same flush toilets and showers. Since we can cut out on our own we plan to do so for a couple of days and head to the area around Nha Trang. In Jan of 1968 our unit suffered its first casualty up there when Ken Lancaster fell from the skid of a helicopter when his team from the MACV Recondo School was extracted after contact. Those who were on the team reported that Ken fell well over 1000 feet into triple canopy jungle. Again those on the team were positive that the fall killed Ken but were not allowed to go back to secure his body. Indeed the coordinates given were approximate and not absolute. Indigenous personnel were sent into the area with no luck. Teams from E/50th volunteered to go look but were advised that area was well outside our AO and were not allowed to go. Well...28 years later four of us are going to go and ask questions of villagers in that area just in case someone might have an answer or two. We realize that to get any kind of information is a million in one shot but if we went that far why not go the extra mile or so. Ken and I came into the unit at about the same time. He was a good guy with a great smile. We cannot afford to forget the good guys or each other. ROY BARLEY






